

2022 Regional Transportation Plan Amendment No. 1

The 2022 Tulare County Regional Transportation Plan (2022 RTP) as amended conforms to the applicable State Implementation Plans (SIPs), meets all applicable transportation planning requirements per 23 CFR Part 450, and meets the transportation conformity regulations. These changes require a formal RTP amendment (new regional emissions analysis). The changes, as described in the table below, are necessary to: 1) add one new project to the 2022 RTP Constrained Capacity Increasing Projects List; 2) change the projects limits of four existing projects; and 3) change the open to traffic dates for nine existing projects. There is no impact to the 2022 RTP fiscal constraint.
