Subject: Approval of Amendment No. 8 (Type 1 - Administrative Modification) to TCAG's 2023 Federal Transportation Improvement Program (FTIP)

Dear Kiranjit,

The Tulare County Association of Government's (TCAG) Executive Director has completed the review of TCAG's Administrative Modification No. 8 to the 2023 Federal Transportation Improvement Program (FTIP). This administrative modification adds programming capacity that relies on the State's federal programming capacity. Our next formal amendment will update the financial information to reflect actual funding to support the added programming capacity.

TCAG's Executive Director has delegated authority to approve administrative modifications to the FSTIP and FTIP in accordance with the revised FSTIP/FTIP Amendments and Administrative Modification Procedures dated December 18, 2019. The approved changes will not impact TCAG's financial constraint or the region's air quality conformity.

The administrative modification is described in the attachments listed below. Under this delegated authority, an administrative modification does not require Federal Highway Administration, Federal Transit Administration or Caltrans approval. This change is effective immediately upon TCAG's approval and is reflected as an administrative modification to California's 2023 FSTIP and TCAG's 2023 FTIP as of the date of this letter.

TCAG certifies that there are no projects in this Administrative Modification No. 8 included in any other amendments that are currently open for public review. Administrative Modification No. 8 to TCAG's 2023 FTIP is available online on TCAG's website at: <u>https://tularecog.org/tcag/programs-funding/federal-transportation-improvment-program-ftip/</u>.

This amendment also includes a technical revision to the 2022 RTP Action Element and Final Conformity Analysis prepared for the 2023 FTIP and 2022 RTP. This technical revision has been prepared to ensure consistency between Tables D-16.1 and D-16.2 in the 2022 RTP and the Regionally Significant Project List found in the Final Conformity Analysis prepared for the 2023 FTIP and 2022 RTP. This has been determined to be a technical revision to the 2022 RTP and Final Conformity Analysis prepared for the 2023 FTIP and 2022 RTP in that this action will not result in any changes to the scope, schedule, or cost of any projects nor will it impact the analysis years for the Sustainable Community Strategy, the Environmental Justice evaluation, or the Air Quality Conformity document.

This technical revision has been prepared to ensure consistency between Tables D-16.1 and D-16.2 in the 2022 RTP and the Regionally Significant Project List found in the Final Conformity Analysis prepared for the 2023 FTIP and 2022 RTP.

The draft Tables D-16.1 and D-16.2 were inadvertently posted on the TCAG website with the final version of the 2022 RTP that was approved by the TCAG Board in August 2022. As a result of this technical revision, the draft Tables D-16.1 and D-16.2 are being replaced by the final Tables D-16.1 and D-16.2 that were approved by the TCAG Board and the Regionally Significant Project List found in the Final Conformity Analysis has been updated to be consistent with final Tables D-16.1 and D-16.2. The projects included in the final Tables D-16.1 and D-16.2 were included in and appropriately accounted for in the air quality modeling that was completed for the 2023 FTIP and 2022 RTP.

This has been determined to be a technical revision to the 2022 RTP and Final Conformity Analysis prepared for the 2023 FTIP and 2022 RTP in that this action will not result in any changes to the scope, schedule, or cost of any projects nor will it impact the analysis years for the Sustainable Community Strategy, the Environmental Justice evaluation, or the Air Quality Conformity document.
