League Cycling Instructors (LCIs)



LCIs are ambassadors for better biking through their education efforts. After earning certification through a three-day, League Coach-led seminar, LCIs can teach a variety of Smart Cycling classes to children as well as adults, helping them feel more confident and secure about riding. From our youth focused classes to our Bicycle Friendly Driver curriculum, LCIs can educate people who bike and drive how to safely and legally share the road.



Day 1: Friday (6/23) I 4:00 – 8:00 PM

Introductions, review of teaching strategies and train the trainer skills.

Day 2: Saturday (6/24) I 8am - 9:30pm

Day time road ride followed by handling and avoidance training drills. Break for lunch. Students given presentations followed by critique. Break for dinner. More student presentations and critique followed by a night ride.

Day 3: Sunday (6/25) I 8am - 3:00pm

Introduction to different types of League Curricular including Smart Cycling, Commuting, Motorists, Kids and Group Riding Skills. Break for lunch. Marketing your classes and final goodbyes.



1. Welcome & Introductions

Patterson (Interest Group #3), Member Dahler (Citizens' Oversight Committee), Member Griswold (City of Woodlake), Member Winton (County of Tulare, Member Cannon (City of Lindsay), Member Forte (TCRTA) and special guest speakers Jarah Crowner (UC Berkeley Safe Trec) and John Liu (Caltrans District 6).

2. Public Comments

Member Corvera shared dates for a community meeting in April to discuss a Cycle 2 Clean CA proposal for the North Visalia area.

5. Information: ATP Program Update

Staff Bhongir said there was nothing new to update on, but the next ATP Cycle 7 will be starting again soon. She shared information on plans to update the Regional Active Transportation Plan so agencies can use it for the next ATP cycle.

6. Action: Choosing a Smart Cycling Class Dates for either May 12/14 or June 2/3 weekends

No action was taken, but schedules and timing conflicts were discussed to help confirm a date for the Smart Cycling class.

7. Special Presentation: UC Berkeley's SafeTrec *free* Online Tool Called <u>Street Story</u> presented by Jarah Crowner

Special guest speaker Jarah Crowner shared a brief presentation and tutorial of the Street Story tool, a free online resource to help communities and grass roots organizations make a case for areas needing improved pedestrian or bicycle infrastructure. Members Winton, Hernandez and Dahler commented on the effectiveness and practical applications of this tool.
