SUMMARY MEETING MINUTES

A. Call to Order & Welcome

The Congestion Management Process (CMP) Steering Committee was called to order by the Chair M. Winton at 1:10 p.m. on April 20, 2022, at the Tulare County Association of Governments, 210 N. Church Street, Suite B, Visalia, CA 93291.

B. Action: Approval of Meeting Minutes

Upon a motion, by Member M. Winton, and seconded by Member M. Miller, the Congestion Management Program (CMP) Steering Committee unanimously approved the Minutes.

C. Public Comments

D. Discussion: Issues from the last CMP meeting - appointments to the CMP Committee

K. Poleszczuk explained the need of the membership roster review since there have been staffing changes within participating agencies. She clarified that committee members need to be appointed by City managers for each jurisdiction and the supervisor or City manager should forward an email to TCAG advising of the change in membership. The selection of the vice-chair was also discussed but this item was tabled until the next meeting.

E. Information:

K. Poleszczuk gave a presentation on the Integration of the CMP with TCAG's Regional Transportation Plan (RTP) and other TCAG planning processes. She presented updated by the latest policies CMP document. D. Winning also gave a presentation on the Streetlight software - a Big Data platform for multimodal transportation metrics. He explained that StreetLight is an online platform that TCAG has a subscription to it. Derek also clarified that with this tool TCAG could better assist agencies to perform various transportation analyses. R. Brady provided an update on TCAG's Activity Base Model (ABM) development. K. Poleszczuk provided an update on the Regional ITS Architecture update and timeline.

F. Discussion: Regional congestion monitoring

K Poleszczuk recommended that because of the time constraints this item be moved to the next CMP meeting.

G. Action: Review and recommend approval of the Final 2022 Congestion Management Process (CMP) K Poleszczuk explained the process of the CMP guidelines update and that it needs to be revised every four years – which is the same schedule as the regional RTP update. Since TCAG is preparing the 2022 update to the RTP, the CMP document needs to be revisited. The CMP document will be finalized in August but then starting in September. M Miller made a motion to approve the CMP document, this was seconded by W. Winton.

F. Other Business

Committee members express a desire to schedule the next CMP meeting in Visalia's TMC and tour the facility. It was established that TCAG staff will follow up with the City of Visalia to schedule a date.
