SUMMARY MEETING MINUTES

A. Call to Order & Welcome

The Congestion Management Process (CMP) Steering Committee was called to order by Chair Mascia at 12:36 p.m. on April 13, 2017 at the Tulare County Association of Governments, 210 N. Church Street, Suite B, Visalia, CA 93291.

B. Action: Approval of Summary Meeting Minutes-Meeting for January 19, 2017

Upon a motion, by Member Hays, and seconded by Member Schenke, the Congestion Management Program (CMP) Steering Committee unanimously approved the January 19, 2017 Summary Meeting Minutes.

C. Public Comments¹

Vice Chair Hays introduced the proposed member representatives to the CMP Committee and stated the new appointments would be submitted to the TCAG board for approval on April 17th.

Upon a motion, by Member Schenke, and seconded by Member Camarena, the Congestion Management Program (CMP) Steering Committee unanimously approved Appointments of the CMP Committee.

E. Action: Approval of CMP Steering Committee Guidelines

Vice Chair Hays requested member comments on the draft CMP Guidelines so they could be adopted by the TCAG board in May.

Committee members requested re-evaluation of term limits under "IV- Terms of Membership" as a smaller city may have difficulty filling the position on the CMP committee and if verbiage could be added for a member to call in approval of a proxy voter.

Vice Chair Hays reported that by committee consensus he would remove term limits and add proxy voting subject to prior notice by the CMP member agency. Vice Chair Hays stated he would email the revised CMP Guidelines to the committee prior to the July TCAG board meeting.ⁱ

Upon a motion, by Member Hays, and seconded by Member Schenke, the Congestion Management Program (CMP) Steering Committee unanimously approved the CMP Steering Committee Guidelines with changes.

F. Information: Update: 2017 Intersection Monitoring Report

Vice Chair Hays reported TCAG should be receiving requested intersections back from data collection soon and once received, analysis would begin and the report should be ready for CMP committee review by the July CMP Steering Committee meeting. Vice Chair Hays requested the committee to review the draft report prior to the meeting so that changes could be determined at the meeting and the report could be adopted at the August TCAG board meeting.

G. Information: Update: iPeMS Third Party Internet Application

Vice Chair Hays discussed the iPeMs Application presented at the last CMP committee meeting which would allow TCAG to do travel-time studies such as the study found on the TCAG website for the SR-190/198 Travel-Time Study. Vice Chair Hays stated the CMP Steering Committee approved the recommendation for purchase and submittal to the TCAG board for adoption during the January 2017 meeting. Vice Chair Hays stated he had scheduled the application for adoption at the May TCAG board meeting and expected, if approved, to have access to the application with a projected travel-time study for SR-63 from Main Street to SR-137 and another study from SR-137 from SR-99 to Lindsay unless the CMP committee opposed. Vice Chair Hays anticipated a draft travel-time study available by the October CMP committee meeting.
