A. Call to order and welcome

The Regional Housing Needs Advisory Committee Meeting (RHNA) was called to order by Ms. McGovern-Garcia at 10:03 am.

B. Public Comments

Public comments opened and closed at 10:03 am. No comments were noted.

C. Approval of March 25, 2021 Meeting Minutes

Member Miller made a motion to approve the minutes, Member Camarena seconded. The minutes were unanimously approved by the committee.

D. RHNA Survey and Methodology Discussion- Steven Ingoldsby

Mr. Ingoldsby discussed key terminology and objectives of the RHNA; how it is used to determine the housing needs for the region over an eight-year planning period.

He provided a brief overview and flow chart of the housing process and how cities in Tulare County prepare housing elements and show how they will accommodate the RHNA.

He shared that the Department of Housing and Community Development (HCD)- provides the number of households and types of households for the region, the income category distributions based on DOF population projection, rates of vacancy and overcrowding, and additional information. He further described how the numbers are used.

Mr. Ingoldsby discussed the RHNA survey and follow up survey that went out and the results that they expect soon and would be shared at the next meeting.

He Further reviewed RHNA Methodology, state law objectives and factors to be addressed such as existing and projected jobs and housing relationship, particularly low wage jobs and affordable housing, opportunities and constraints to development of additional housing, distribution of household growth, housing needs of farm workers, and GHG targets.

Mr. Ingoldsby discussed the methodology from the previous cycle and the timeline for the RTP adoption target date of June 2022 and updated housing elements within 18 months.

He stated that the HCD final RHNA determination was scheduled for December 2021 and a draft determination was expected in a few weeks. The proposed methodology would go before the TCAG Board in summer 2021.

Mr. Ingoldsby stated that they would start a similar path for the committee and will have survey results at the next meeting.

RTP/SCS Minutes

A. Call to Order and Welcome

Meeting was called to order by Chair Livingston at 10:03 a.m. on March 25, 2021.

B. Public Comments

Public comments opened/closed at 10:06 a.m. No public comments were noted.

C. Action: Minutes of the February 25, 2021 Meeting

Upon motion by Member Allen and second by Member Mascia, the minutes were unanimously approved.

D. SCS/Demographic Forecast Update – Roberto Brady

Mr. Brady introduced the forecast and Mr. Winning and he reviewed the Demographic forecast highlighting the Blueprint scenario and discussing projection details, California trends, Tulare County Trends and methodology of the DOF. Discussion ensued regarding general plan development patterns and the RTP.

E. Update the 2018 Policy Element – Ben Kimball

Mr. Kimball discussed system goals and changing the order of the Goals such as establishing the EJ goal as number two and Rail as number three. He also discussed making them more understandable to a wider audience.

Julie page A-5 service level Policies 1. Service level C & D clarification. Derek and Roberto discussed and provided clarification of service level performance efficiency and how it works. Ben discussed recent legislation that has us look at VMT instead of LOS according to SB743.

Discussion ensued regarding land use planning, new development, parking requirements in urban areas and associated issues.

Mr. Livingston discussed groundwater recharge systems and projects- Ben stated that he would look into it and follow up in this regard.

Mr. Wall discussed barrier studies and Mr. Kimball provided examples of such in communities such as Goshen. What barriers exist physically that makes it difficult for people to get around. These often are in the form of complete streets studies. Mr. wall recommend rewording of this item for clarification. Ms. Allen asked how Cap and trade might figure into all of this. Mr. Kimball mention AHSC grants and projects. These pay for related transportation around that housing such as pedestrian pathways and other related improvements.

Ms. Allen discussed the Zero emission corridor idea and the feasibility of it. Mr. Kimball further discussed the I5, electric highway and a dedicated electric lane.

Ms. Escobedo mentioned site EV infrastructure in EJ communities similar to Fresno Counties. Bike sharing or community solar projects, or transition from propane to electrification. Ms. Escobedo provided Fresno county as an example of Cantua Creek and said she would provide more information on that.

Mr. Kimball discussed EV car sharing in Tulare County and difficulties with funding. Ms. McGovern-Garcia further discussed Miocar charging infrastructure in communities and providing a renewable energy source for disadvantaged communities. Mr. Kimball talked about the effort to have a policy that clarifies that.

Discussion ensued regarding autonomous vehicles and if it was included in the policy element. Mr. Kimball replied that this would have a region-specific application, but it hadn't yet connected to local transportation issues. Additionally, he shared that parking, and other items may need context and Mr. Winning shared regarding the section about technology.

Adjourn as the RTP/SCS Roundtable Committee and convene as the Rural Communities Committee.
