#### **Summary Meeting Minutes**

#### 1. Welcome & Introductions

The Sustainable Corridor Committees (SCCs) Joint Meeting was called to order by the Committee Chair, Dennis Townsend at 10:05 a.m. on January 20, 2022.

#### 2. "Clean California" - Presentation

It was requested to move agenda item 4 to the front. C. Hatton provided an update on the Clean California Program that will be funding local beautification projects through \$296 Million in Clean California Grants.

He spoke about potential projects – a combination of adding beautification measures and art in public spaces along with the removal of litter and debris, this effort will enhance communities and improve spaces for walking and recreation. B. Cole also provided an update on roadside design features and screening project techniques

#### 2. Public Comments

Public Comments opened/closed at 10:20 a.m. No comments were received.

#### 3. Action: Approval of Meeting Minutes

Minutes for September 9, 2021 were approved upon a motion by Member Flores, and second by Member Schoettler.

#### 4. Corridor Beautification Strategies / Update

Member J. Ridenour presented current City of Porterville efforts for Litter Abetment partnership with Caltrans and Mighty 190 corridor projects. He also talked about the progress of the Litter Abetment Pilot Program – an agreement that the city was currently working on with Caltrans and TCAG and CSET on corridor cleaning. Also discussed design features and partnership with Caltrans roadside design features.

#### Screening Unsightly Views – Project list & PSRs (TCAG, B. Cole)

B. Cole, landscape architect with Caltrans District 6, provided an update on roadside design features and screening projects techniques for nominated in Tier 1 screening projects. He highlighted a few specific projects in the city of Porterville that Caltrans is currently working on planting and irrigation plans.

#### **Community Identifiers ("Mighty 190")**

TCAG staff D. Winning provided an updated on the priority projects and discussed screening methods to hide unsightly views alongside the highways, and landscaping to improve aesthetics and prevent unkempt visuals, or maintenance for the landscaping at the sites.

#### **5. Corridors Update**

SCCs members provided updates on current agencies efforts to beautify highways in Tulare County.

#### 6. Schedule Next Meeting

Committee members discussed a date for the next meeting, which was tentatively set for the April 9th, 2022.
