SUMMARY MEETING MINUTES

Public Comments

No public comments were received.

I. Welcome & Introductions

The Social Services Transportation Advisory Council (SSTAC) was called to order by Chair Fox at 9:02 a.m. on May 9, 2023. Persons in attendance noted presence over Zoom teleconference.

II. Action: Approval of Minutes

Upon a motion by Member Mauro and a second by Vice Chair Donabed, the minutes from February 14, 2023, were approved. Draft minutes from November 8, 2022, were also approved unanimously upon a motion by Member Verduzco and a second by Member Ortega.

III. Action: Adoption of 2023-24 Meeting Schedule

Chair Fox introduced the item and Mr. Bruno presented the proposed times. Member Verduzco noted a correction to the proposed February date; it should be February 6, 2024, rather than the February 8, 2024, originally stated. Schedule was approved on a motion by Vice Chair Donabed and a second by Chair Fox.

IV. Action: Election of Chair and Vice Chair for 2023-24

Chair Fox and Vice Chair Donabed both indicated a willingness to continue in their respective positions. Chair Fox invited other interested members to submit their nominations, no other nominations were submitted. Chair Fox and Vice Chair Donabed were unanimously elected.

V. Action: 2023 Unmet Transit Needs Review and Recommendations

Chair Fox introduced the item and proposed a system in which each comment would be given one of five (5) designations:

- 1) An unmet transit need that is reasonable to meet.
- 2) An unmet transit need that is *not* reasonable to meet.
- 3) An Operational Issue.
- 4) Feedback/Comments.
- 5) Service is currently provided.

The Council deliberated to place each comment into one of the above-referenced categories. Upon completing their review of all comments received, they recommended the following six (6) items be deemed "unmet transit needs that are reasonable to meet":

1) Tulare County Regional Transit Agency (TCRTA) shall post current schedules at all its transit centers and timepoint stops.

2) Regional microtransit service shall be provided and shall include service to the communities of Matheny Tract, Pixley, Seville, Springville, Tooleville, Terra Bella, and Yettem. Matheny Tract and Tooleville shall be included in the greater Visalia service area.

3) TCRTA shall restore transit services to the Tule River Indian Reservation upon finalizing a service agreement with Tribal authorities.

4) TCRTA and Visalia Transit shall begin sale of senior/ADA/military-discounted T-Passes to eligible buyers.

5) TCRTA shall install a bus stop sign and bench at the North Park Apartments stop on N. Crawford Ave. in Dinuba.

6) Visalia Transit shall address comments regarding Northside transit service by improving access and reducing travel times between downtown and the Orchard Walk shopping center.

VI. Other Items/ Future Agenda Requests

Vice Chair Donabed recommended a future agenda item to provide increased training and awareness of issues faced by transit riders with disabilities to transit drivers. Mr. Barragan and Member Bowman provided some brief information about their driver training to ensure that the needs of riders with disabilities are being attended to properly.

Chair Fox requested an update on microtransit for the August agenda.

VII. Adjournment.

The meeting was adjourned at 1:05 pm on May 9, 2023.
