SUMMARY MEETING MINUTES

Public Comments

No public comments were received.

I. Welcome & Introductions

The Social Services Transportation Advisory Council (SSTAC) was called to order by Chair Fox at 10:00 a.m. on August 10, 2021. Persons in attendance noted presence over Zoom teleconference.

II. Action: AB 361 Emergency Certification

Upon a motion by Member Mauro and a second by Member Esquibel, the motion was approved unanimously.

III. Action: Approval of Minutes

Minutes from the May 10 & 17, 2022 were unanimously approved, with the request that language of unmet transit need reasonable to meet #5 be amended as described below, upon a motion from Vice Chair Donabed and a second by Member Esquibel.

IV. Discussion: 2021/22 Unmet Transit Needs Follow-Up

Chair Fox initiated the discussion on this year's unmet transit needs. Mr. Bruno shared the finalized list of six (6) unmet transit needs reasonable to meet and outlined each request.

Chair Fox asked about how the SSTAC and TCAG can make sure that unmet needs reasonable to meet are addressed. Mr. Bruno stated that depending on the depth of the issue it might be necessary to consider good faith efforts on the transit agencies to resolve long term issues.

Vice Chair Donabed and Chair Fox discussed in detail issues regarding the ADAmandated stop announcements. Chair Fox noted that in his experience Dinuba was the only area where the drivers fully complied with this requirement. He said that he was interested to hear from the operating contractors about what was being done to bring about a definitive resolution.

Mr. Boulware of Transdev responded that Transdev is currently making a full-fledged effort to bring all automated PA systems back into operation and to stress to drivers the importance of the requirement to make stop announcements in the interim. He noted that they are performing internal audits to ensure drive follow-through.

Mr. Tree added that he appreciates that it is evident that Transdev is taking the issue seriously, particularly given that they have only started operating TCRTA services in the last 30 days.

Chair Fox and Vice Chair Donabed expressed their frustration with some drivers that do not make stop announcements as required. Mr. Bowman described Visalia Transit's efforts to systematically address the problem. Mr. Rucker explained that Visalia Transit is repairing the automated PA systems as they are reported as nonfunctional and stressed the difficulty of making an announcement that would be clearly audible from the back of the bus without the aid of the intercom.

V. Discussion: SSTAC Ride and Report

Chair Fox expressed the desire to provide SSTAC members with T-Passes and set up a 'Ride and Report' day for September. He lamented the fact that last year only he and Vice Chair Donabed participated in a similar effort and implored the other members to use the transit system at least one day before the next meeting. Members present agreed to meet at the Visalia Transit Center at 9:00 am on September 13th.

VI. Introduction to TransPort

Mr. Tree gave a presentation on the recently introduced TransPort microtransit ondemand service. He highlighted some of the difficulty local commuters have with lowfrequency, long distance commuter routes that are typical in Tulare County. He highlighted some of the beneficial use cases for the new service and discussed its upcoming expansion beyond the Porterville area.

VII. Transit Provider Updates

a. Visalia Transit

Mr. Bowman shared recent ridership data from Visalia Transit, including V-Line and Dial-a-Ride services. Chair Fox and Member Stewart shared their disappointment with the current configuration of Route 7.

b. Tulare County Regional Transit Agency (TCRTA)

Mr. Tree noted that small service improvements and schedule adjustments will soon be introduced by TCRTA. He added that the Free Fares for All program will end on August 31st, after which point the new regionwide fare structure will be introduced. He also shared that regional one-day, 7-day, and 31-day passes will be available once the necessary equipment is installed across the whole fleet.

VIII. Social Service Provider Updates

No social service provider updates were provided.

IX. Other Items/Future Agenda Items Requests

No requests for future items were received.

X. Adjournment.
