#### **SUMMARY MEETING MINUTES**

#### **Public Comments**

May 17: Member Stewart apologized to those present for having to suddenly depart from the May 10<sup>th</sup> meeting.

#### I. Welcome & Introductions

The Social Services Transportation Advisory Council (SSTAC) was called to order by Chair Fox at 10:00 a.m. on May 10, 2022. Persons in attendance noted presence over Zoom teleconference.

#### II. Action: Adoption of AB 361 Declaration

A motion was made by Vice Chair Donabed to adopt the declaration, seconded by Member Mauro, unanimously adopted.

#### III. Action: Approval of Minutes

Minutes from the February 8, 2022, meeting were approved unanimously, upon a motion from Member Stewart and a second by Vice Chair Donabed.
