Summary Meeting Minutes

1. Welcome & Introductions

The Sustainable Corridor Committees (SCCs) Joint Meeting was called to order by the Committee Chair, Dennis Townsend at 10:10 a.m. on November 9, 2020.

2. Public Comments

Public Comments opened/closed at 10:15 a.m. No comments received.

3. Action: Approval of Meeting Minutes

Member Flores pointed out an error to minutes regarding two members who were counted, as present during the February meeting, which was recorder incorrectly. The amendment to February minutes was noted.

Minutes for February 20, 2020 were approved upon a motion by Member Valero, and second by Member Flores.

3. Information: "Measure R" Amendment and project funding opportunities

TCAG Director Smalley discussed partnership with Caltrans and opportunities for funding for needed improvements along the corridors. He mentioned that Measure R has funding available for SR 65, South SR 99, SR 190, and SR 198 improvements. He also stressed the importance of getting aesthetic enhancements included during the design phase of major freeway and

interchange projects. It is also important that the committees work to help identify appropriate corridor themes that could be incorporated as major projects come online. ATP grant funds may be a source of funding for complete streets improvements on state highways in communities along the corridors.

4. Corridor Beautification Strategies / Update

Discussion - Priority Projects

TCAG staff Poleszczuk and Winning provided an updated on the priority projects. Members discussed screening methods to hide unsightly views alongside the highways, and landscaping to improve aesthetics and prevent unkempt visuals, or maintenance for the landscaping at the sites.

Screening Unsightly Views – Project list & PSRs (TCAG, B. Cole)

Brad Cole, landscape architect with Caltrans District 6, provided an update on roadside design features and screening projects techniques for nominated in Tier 1 screening projects.

Community Identifiers ("Mighty 190")

Jason Ridenour from the City of Porterville gave a presentation on current City efforts for beautifying the 190 corridor. Also discussed design features and partnership with Caltrans roadside design features.

5. December Board Presentation - Discussion (TCAG, SCCs)

TCAG staff and SCCs members discussed a content of the staff report on committee so far work that is scheduled for December meeting.

6. Corridors Update

SCCs members provided updates on current agencies efforts to beautify highways in Tulare County.
