SUBJECT:

Action: Adoption of Resolution: Reaffirm 2021 Federal Transportation Improvement Program (FTIP) Amendment No. 4 (Type 3-Formal Amendment)

BACKGROUND:

The Federal Transportation Improvement Program (FTIP) is the four-year capital improvement program that details project funding and allows the approval to expend the funds. From time to time, project details change (e.g., scope, cost, or schedule) or new projects need to be added. In these cases, the FTIP must be amended to reflect the project changes and additions. Different types of amendments depend on the type of change requested. The FTIP is subject to federal air quality conformity rules established by the Environmental Protection Agency (EPA).

DISCUSSION:

The project changes from this amendment have been determined to be exempt from the requirement that a conformity determination and/or regional emissions analysis be performed. The summary of changes (see Attachment 2) provides a detailed description of the project changes as a result of Amendment No. 4.

Per TCAG's adopted 2015 Public Participation Plan (PPP), a 14-day public review period was held and no comments were received during the public review period. The Executive Director has delegated authority to approve Type 3 formal amendments with reaffirmation by the TCAG Board. Amendment No. 4 was approved by the Executive Director on May 27, 2021. Caltrans approved the amendment on June 11, 2021, followed by approval by FHWA on July 2, 2021.

FISCAL IMPACT:

There is no fiscal impact to TCAG. Any fiscal changes to TCAG agencies are listed in the attached project summary.

WHEREAS, federal planning regulations require the MPO to prepare and adopt a long range Regional Transportation Plan (RTP) for their region; and

WHEREAS, federal planning regulations require the MPO to prepare and adopt a Federal Transportation Improvement Program (FTIP) for their region; and

WHEREAS, Amendment No. 4 to the 2021 FTIP has been prepared to comply with Federal and State requirements for local projects and through a cooperative process between the Federal Highway Administration (FHWA), the Federal Transit Administration (FTA), the State Department of Transportation (Caltrans), principal elected officials of general purpose local governments and their staff, and public owner operators of mass transportation services acting through the Tulare County Association of Governments forum and general public involvement; and

WHEREAS, Amendment No. 4 to the 2021 FTIP program listing is consistent with: 1) the 2018 Regional Transportation Plan; and 2) the 2020 State Transportation Improvement Program (STIP); and 3) the Corresponding Conformity Analysis: and

WHEREAS, Amendment No. 4 to the 2021 FTIP contains the MPO's certification of the transportation planning process assuring that all federal requirements have been fulfilled; and

WHEREAS, Amendment No. 4 to the 2021 FTIP meets all applicable transportation planning requirements per 23 CFR Part 450; and

WHEREAS, Amendment No. 4 to the 2021 FTIP includes funding changes and additions and deletions of projects exempt from air quality conformity; and

WHEREAS, projects submitted in Amendment No. 4 to the 2021 FTIP must be financially constrained and the financial plan affirms that funding is available; and

WHEREAS, Amendment No. 4 to the 2021 FTIP does not interfere with the timely implementation of the Transportation Control Measures; and

WHEREAS, Amendment No. 4 to the 2021 FTIP conforms to the applicable State Implementation Plan (SIP); and

WHEREAS, the documents have been widely circulated and reviewed by TCAG's advisory committees representing the technical and management staffs of the member agencies; representatives of other governmental agencies, including State and Federal; representatives of special interest groups; representatives of the private business sector; and residents of Tulare County consistent with the Public Participation Plan (PPP) adopted by TCAG; and

WHEREAS, a 14-day interagency consultation and public comment period was held between Wednesday, May 12, 2021 and Wednesday, May 26, 2021; and

WHEREAS, on April 20, 2009, TCAG approved the 2009 PPP, delegating authority to the TCAG Executive Director to approve Type 2 and 3 Amendments to the FTIP and on September 15, 2011, TCAG approved Amendment No. 1 to the PPP which delegated final approval authority for Type 1 administrative modifications to the FTIP to the TCAG Executive Director and TCAG Chair.

SUBJECT:

Action: Adoption of Resolution: Reaffirm 2021 Federal Transportation Improvement Program (FTIP) Amendment No. 5 (Type 5-Formal Amendment)

BACKGROUND:

The Federal Transportation Improvement Program (FTIP) is the four-year capital improvement program that details project funding and allows the approval to expend the funds. From time to time, project details change (e.g., scope, cost, or schedule) or new projects need to be added. In these cases, the FTIP must be amended to reflect the project changes and additions. Different types of amendments depend on the type of change requested. The FTIP is subject to federal air quality conformity rules established by the Environmental Protection Agency (EPA).

DISCUSSION:

Amendment No. 5 to the 2021 FTIP was required in order to make changes to the City of Visalia's Riggin Avenue Widening Project. The project consists of the widening of various sections of Riggin Avenue (between Road 80 and State Route 63) from 2 to 4 lanes. Prior to the approval of FTIP Amendment No. 5, the project was listed in the 2021 FTIP and 2018 RTP as one single project with an open to traffic year of 2024. The project was split into separate segments to allow for the timely use of available federal funds (STBGP and HIP1). Splitting the projects into separate segments will also result in certain segments being open to traffic earlier than shown in the FTIP and RTP, which requires the need for air quality conformity analysis. The summary of changes is included as Attachment 2 and provides a detailed description of the project changes.

As per TCAG's adopted 2015 Public Participation Plan (PPP), a 30-day public review period was held, which began on June 14, 2021, and ended on July 14, 2021. No comments were received during the public review period. As approved by the TCAG Board on August 19, 2019, the Executive Director now has delegated authority to approve Type 4 and 5 formal amendments with reaffirmation by the TCAG Board. Amendment No. 5 was approved by the Executive Director on July 14, 2021. Caltrans approval was received on July 27, 2021, followed by FHWA/FTA approval on August 14, 2021.

FISCAL IMPACT:

There is no fiscal impact to TCAG. Any fiscal changes to TCAG agencies are listed in the attached project summary.

SUBJECT:

Information: Senate Bill 1 (SB 1) Competitive Programs Update

BACKGROUND:

On April 28, 2017, Governor Brown signed Senate Bill 1 (SB1) (Beall, Chapter 5, Statutes of 2017), which is also known as the Road Repair and Accountability Act (RMRA) of 2017. This Act provides the first significant, stable, and ongoing increase in state transportation funding in more than two decades. In providing this funding, the Legislature has provided additional funding for transportation infrastructure, increased the role of the California Transportation Commission (CTC) in a number of existing programs, and created new transportation funding programs for the CTC to oversee.

The purpose and intention of the Act is to address basic road maintenance, rehabilitation, and critical safety needs on both the state highway and local streets and road systems as well as provide transit assistance. SB1 affected eight different transportation funding programs including the Local Partnership Program (LPP), Trade Corridor Enhancement Program (TCEP), Solution for Congested Corridors Program (SCCP), and the Active Transportation Program (ATP).

DISCUSSION:

LPP, TCEP, and SCCP

On August 24, 2021 TCAG staff attended (via virtual meeting format) the 2022 All SB 1 Competitive Programs Kick-off Workshop. Introductory presentations of each of the SB1 programs were made by CTC staff. The kick off meeting was very general in nature. More in-depth discussions related to the guidelines, selection criteria, etc. will occur during the SB1 workshops planned later this fall and into 2022. Information: Status of State Transportation Improvement Program (STIP) Allocations and California Transportation Commission (CTC) Update

BACKGROUND:

The CTC is responsible for the programming and allocating of funds for the construction of highway, passenger rail and transit improvements throughout California. The CTC met via webinar/teleconference on August 18th-19th. The next CTC meeting via webinar/teleconference is on October 13th-14th. The STIP is a biennial document, which covers five years of programming for transportation projects in California. The STIP is comprised of Regional Transportation Improvement Programs (RTIPs) from each of the counties in California and the Interregional Transportation Improvement Program (ITIP) that is developed by Caltrans. The RTIPs account for 75% and the ITIP accounts for 25% of the total STIP funding.

DISCUSSION:

August CTC Meeting

State Highway Operation and Protection (SHOPP) allocations:

- \$15.7 million for construction replacing the Yokohl Creek and Kaweah River bridges on SR-245 near Woodlake.
- \$9.89 million for construction at the Raine rest area near Tipton to upgrade water, sewer and irrigation.
- \$2.25 million PS&E and \$750k R/W support for the SR-216 rehabilitation/Lovers Ln IC operational improvements project.

June CTC Meeting

Presentation & Information: California Department of Public Health (CDPH) Kids' Plates Grant for Childhood Unintentional Injury and Illness Prevention

BACKGROUND:

In July 2021, TCAG administrative staff applied for the CDPH grant after California Kid's Plates program released the Request for Application (RFA) No. 21-10210 on June 15, 2021. TCAG staff informed the Board of intent to apply for the grant at the June 28, 2021 Board meeting.

Additionally, TCAG administrative staff informed the Board of the Kids' Plates Equipment Grant applied for and awarded to TCAG. This grant supplied TCAG with 100 bike/multisport helmets and 30 convertible vehicle safety seats.

DISCUSSION:

On August 12, 2021, CDPH announced that TCAG had been awarded \$150,000 for the Kids' Plates Childhood Unintentional Injury Prevention grant. Ten total applications were received, of which seven were indicated as tentative award recipients. The grant will provide two reimbursements of \$75,000 per grant year over a total grant period of 21 months from October 1, 2021, to June 30, 2023.

Per grant award guidelines, the TCAG workplan for the funding will focus on unintentional childhood injury prevention. Given TCAG's history of active participation in bike rodeos, active transportation awareness initiatives, and national safety campaign interventions such as Rail Safety Month and Safe Routes to School, implementation of grant projects will find effortless alignment with ongoing TCAG enterprises. Intended projects include child safety seat community installation, training, and dissemination events; bike rodeos and multisport safety equipment dissemination and targeted safety training; bilingual multimedia safety campaigns; and promotion of national active transportation events.

Based on public health data for Tulare County, young TCAG constituents stand to gain considerable benefit from unintentional injury prevention interventions. Local youth face significantly higher statistical likelihood of unintentional injury and death based on demographic factors like the number of children living in rural communities; the extent to which children live in poverty; the number of households living without a person over the age of 14 who is comfortably fluent in English; the lack of access to medical professionals who speak languages other than English; and the relative lack of community resources in Tulare County compared to the rest of the state of California. In general, Tulare County also showed higher rates of childhood hospitalizations, emergency room visits, and

deaths resulting from bike, pedestrian, and/or motor vehicle occupant-related injuries compared to the state.

FISCAL IMPACT:

This grant does not require a match and staff time is built into the cost of outreach efforts. There is no fiscal impact besides the staff time allocated for grant preparation.



SUBJECT:

Information: Implementation Status of Federally Funded Projects

BACKGROUND:

The **Surface Transportation Block Grant Program (STBGP)**, formerly known as STP, is a major source of funds that may be used by local agencies for projects to preserve and improve the transportation system consistent with regional priorities. The funds may be utilized on any Federal-aid highway, including the National Highway System (NHS), bridge projects on any public road, transit capital projects, and intracity and intercity bus terminals and facilities. In Tulare County, these funds have been primarily used for street and highway construction, reconstruction, rehabilitation, resurfacing, and operational improvements. Local agencies navigate a sometimes-complicated federal aid funding process to request and spend these funds in a timely manner. However, through our partnership with Caltrans, TCAG has helped local agencies with the timely and efficient delivery of their projects.

The Congestion Mitigation and Air Quality (CMAQ) Program has been a longstanding source of funding for TCAG's member agencies. Tulare County agencies qualify for funding due to the region being in a non-attainment area for meeting federal air quality standards for Particulate Matter (PM) and Ozone. The program exists under federal law and is implemented via guidance issued by the Federal Highway Administration and carried out by Caltrans. TCAG received estimates for the receipt of approximately \$6.2 million per year for the next four-year cycle. Project examples include roundabouts, signal coordination, compressed natural gas and electric facilities and vehicles, transit route expansion and bus purchases, etc.

DISCUSSION:

STBGP

As the Metropolitan Planning Organization for the Tulare County region, TCAG is responsible for soliciting projects from eligible agencies for programming in the FTIP and ensuring that the funds are being utilized appropriately and are obligated in a timely manner. In FFY 20/21, \$3.6 million in STBGP funds were obligated on two roadway rehabilitation projects (in the City of Visalia and County of Tulare). Next FFY (21/22), there is \$4.3 million in STBGP programmed on the City of Visalia's Riggin Avenue Widening Project. Beginning in federal fiscal year (FFY) 22/23, TCAG will begin distributing federal STBGP funds on a competitive basis. The call for projects is scheduled for the fall 2021. Selected projects will be programmed in the current and future FTIPs.

CMAQ

Two roundabout projects were scheduled for obligation this year and both have been obligated:

City of Dinuba: Roundabout at Alta and Nebraska

- CMAQ: \$1,015,000

City of Woodlake: Roundabout at Sierra and Castle Rock

- CMAQ: \$1,970,000

Two transit project were able to be advanced this year. Three electric buses were approved for the City of Porterville. The CMAQ amount is \$2,055,000 and the match is \$693,000. Visalia Transit also received \$1,386,000 in CMAQ funds to support a new transit route to the Industrial Park. The route is scheduled to begin on October 3, 2021.

Information: 2022 Regional Transportation Plan (RTP)/Sustainable Communities Strategy (SCS) Update

BACKGROUND:

The Regional Transportation Plan (RTP) is a 20-year planning document that TCAG updates at least once every four years. The RTP is the highest level and most comprehensive planning document prepared by TCAG. The 2022 RTP will outline transportation improvements and other related planning elements through the year 2047. Planned transportation improvements must be financially constrained, based on funding estimates, and performance measures should be defined.

Progress so far on the development of the RTP/SCS has included:

- Formation of the RTP Roundtable
- Formation of the RTP Rural Communities Committee
- Formation of the RHNA Housing Subcommittee
- Development and Review of Draft Policies
- Nearing completion of the modeling work
- Development of SCS Scenarios
- Preparation of and Environmental Impact Report (EIR)
- Preparation of an Environmental Justice Study
- Preparation of a Health Impact Analysis
- Update of the Regional Active Transportation Plan
- Update of the Regional Transit Plan
- Preparation of additional County Complete Streets Plans
- Preparation of a 2022 RTP Public Outreach Plan
- Preparation of a 2022 RPT Tribal Public Outreach Plan
- Participation in a Valleywide Regional Early Action Planning Committee for housing
- Preparation of a Regional Housing Allocation Plan and new development factors
- Air Quality Conformity Document Preparation
- Federal Transportation Improvement Program Update

DISCUSSION:

As part of the Sustainable Communities Strategy (SCS) process, three growth scenarios are being developed to compare how different growth influences and policies can impact greenhouse gas emissions and the transportation system. This scenario becomes the foundation of the SCS analysis that complements the RTP.

A presentation of these scenarios will be made at the Board meeting and members of the public in attendance will be invited to participate in a survey that will include scenario preference that will then be used with the remainder of the public input to inform the Board's decision on a preferred scenario later in the year.

These scenarios will also be presented to the public during the public outreach process and the results of the public outreach are communicated back to the TCAG Board to inform their decision on the selection of a preferred scenario at the following locations:

The meeting was called to order by Mr. Brady at 1:32 p.m.

Mr. Bruno gave an update on the state of good repair projects and reviewed the three projects including a new one for TCRTA.

Mr. Brady stated that there was an interagency consultation call that week and on July 22, a partial approval and disapproval on the non-attainment plan and if the decision became final, it would create a conformity freeze on amendments to the FTIP and RTP for a period of 1-3 months.

Mr. Brady summarized activities for outreach and relayed the final budget information and expenditures. Also, he mentioned that there was a balance of \$29,000 due to Covid 19 issues and further highlighted the redistributing efforts and data releases.

Raine rest area in Tipton at 9.9 million to upgrade water, sewer, and irrigation, and second would be the bridge replacement and construction projects at 15.7 million on the Yokohl Creek bridge and the Kaweah River bridge.

SUBJECT:

Action: Adoption of Resolution: Creation of Additional Social Services Transportation Advisory Council Position, Increasing Membership to Eleven (11) Members

BACKGROUND:

The Transportation Development Act (TDA) requires each regional transportation planning agency (RTPA) to provide for the establishment of a Social Services Transportation Advisory Council (SSTAC). The SSTAC is a volunteer body responsible for advising the RTPA on transit issues, particularly those related to human services transportation and priority populations, and for making recommendations on which comments received as part of the annual 'Unmet Transit Needs' process constitute unmet transit needs that are reasonable to meet. These recommendations provide the basis for the formal Unmet Transit Needs Finding adopted by the TCAG board for submittal to Caltrans.

Membership is comprised of 10 members representing local transit operators, social services providers, and potential transit users from certain transit reliant populations.

DISCUSSION:

Presently there is a single vacancy on the Council, caused by the recent departure of its representative from local youth. To date no applications have been received for the vacant position, which is reserved for county residents aged 25 or younger. A notice advertising the vacant position has been posted to the TCAG website.

During the August meeting, the Council discussed the SSTAC composition. They believe it is skewed towards social service and transportation providers rather than transit riders in the community. People with a disability or disabilities ride transit at significantly higher rates than average for Tulare County and there are multiple community members interested in serving on the SSTAC in this capacity. Therefore, the creation of a second position on the Council for a 'Representative of Potential Transit Riders with a Disability' is recommended by staff to allow more direct participation by members of this transit-reliant population. This is particularly appropriate considering the SSTAC's role in the annual unmet transit needs process.

RECOMMENDATION:

Create a second 'Representative of Potential Transit Riders with a Disability' position on the Social Services Transportation Advisory Council, increasing membership to eleven members.

FISCAL IMPACT:

There is no fiscal impact to TCAG. The SSTAC is required under state law.

SUBJECT:

Action: Adoption of Resolution: Approve Trinity Consultants, Inc. for On-Call Air Quality Planning and Conformity Consulting Services

BACKGROUND:

Air quality requirements in the San Joaquin Valley are very unique and dynamic. Greenhouse gas requirements are relatively new and still evolving in their implementation. Tulare County may see new requirements or Transportation Control Measures (TCMs) in a future State Implementation Plan (SIP) or require assistance in emissions reductions calculations for projects or the Sustainable Communities Strategy (SCS) as examples.

TCAG, as the designated Metropolitan Planning Organization (MPO) for the Tulare County region, is the lead agency responsible for developing the Regional Transportation Plan (RTP). This entails, among other tasks, demonstrating the RTP meets transportation conformity requirements under the Clean Air Act. As a component of the RTP, TCAG must also analyze greenhouse gas emissions in the SCS and show that it meets the requirements of the Sustainable Communities and Climate Protection Act of 2008 (SB 375).

Trinity Consultants, by virtue of acquisition of Sierra Research, Inc. in 2014, has a long resume of work on air quality issues in the San Joaquin Valley, and in California generally. Trinity Consultants previously had an on-call air quality support agreement with TCAG and currently has one for working with the eight San Joaquin Valley MPOs as a group on air quality issues.

DISCUSSION:

Because of their extensive direct experience with the issues of immediate bearing to TCAG's current RTP/SCS update, it is most timely and efficient to engage Trinity Consultants for the support services requested under a sole source procurement rather than an RFP process. Other technically qualified firms would face a significant learning curve.

TCAG's Overall Work Program for Fiscal Year 2021-22 already authorizes the tasks that is agreement would support.

RECOMMENDATIONS:

Staff recommends Trinity Consultants, Inc. to provide on- call air quality planning and conformity supports services under a three-year agreement.

Board selection will allow TCAG staff to negotiate and execute a contract with Trinity Consultants for said services for costs not to exceed the amount of \$16,000 for FYs 2021/2022, 2022/23 and 2023/24 under TCAG's sole source procurement policies and procedures.

The cost under this contract will not exceed \$16,000 for FYs 2021/2022, 2022/23 and 2023/24.

A Sole Source Policy exists when research has determined that one of the criteria below exists.

Tulare County Association of Governments intends to negotiate a sole source services contract for services of not more than \$50,000, for existing authorized tasks or projects adopted within the current fiscal year Overall Work Plan (OWP). Advanced written notice will be provided to the Tulare County Association of Governments Board and/or Tulare County Transportation Authority for any additional or new projects or tasks for approval. Consideration will be given to qualified local firms.

In addition, a completed sole source justification form for approval of a sole source contract must include authorized signature by the Chair of the TCAG Board, and the Executive Director or Deputy Executive Director (sample of form attached).

The Services could be considered a sole source procurement when one of the following circumstances exist (other than the financial requirement):

- 1. Quick action is required (urgency situation)
- 2. Additional services are needed to complete an ongoing task and it would be prohibitively costly in time and money to seek a new service provider
- 3. It is more cost-effective to obtain services by exercising an option under an existing contract
- 4. It is in the best interest of the association, e.g., administrative cost savings, excessive learning curve for a new service provider, etc.

Procedures

- Sole Source Justification Form indicating the reason the service is declared a sole source procurement.
- If amount is \$25,000 or greater three (3) informal quotes must be solicited and attached with request
- If sole source request is for a new project or task such must have advanced written notice to TCAG and TCTA before the sole source request can be considered
- Send the completed Sole source justification form to the Chair of the TCAG Board and Executive Director or Deputy Executive Director for approval
- If approved, post sole source procurements on Web site five (5) business days prior to a contract being award

The Association Executive Director or Deputy Executive Director is required to report to the Tulare County Association of Governments and/or Tulare County Transportation Authority Board by the board meeting following the procurement. Annually the Fiscal Manager shall compile the sole source listing and submit it to the Tulare County Association of Governments/Tulare County Transportation Authority Boards in July of each year.

SUBJECT:

Information: Legislative Update

BACKGROUND:

Every year, TCAG holds one or more One Voice trips to Washington, D.C. to collaborate with administration and legislative bodies on matters of federal policy and financing. TCAG also participates in legislative efforts and Valley Voice trips conducted by the San Joaquin Valley Policy Council, both to Washington, D.C. for federal matters and Sacramento for state matters.

In addition, TCAG works with the California Councils of Government (CalCOG), the Self-Help Counties Coalition (Self-Help), the American Planning Association (APA) and the National Association of Regional Councils (NARC) to advance the regional agenda and get additional support from the federal and state government.

Assisting TCAG staff in these efforts is our federal lobbyist, Pace Government Solutions, and our State Lobbyist the Politico Group.

DISCUSSION:

The successful awarding of a federal grant for the Commercial Interchange on SR 99 was the capstone achievement of legislative efforts in 2020. TCAG is analyzing our legislative platform for opportunities and strategies to build our state and federal partnerships and find solutions to our needs. TCAG will be involved in any discussions regarding a federal transportation bill and continue to seek policies and funding that is favorable to our projects, especially those serving disadvantaged communities. Information: Vacancy of Alternate Member at Large Position No. 2

BACKGROUND:

The TCAG Board is made up of eight city representatives, Tulare County Board of Supervisors, one public transit provider and three At-Large members. At-Large Board members are not appointed based on geographic location in the County. At-Large Board Members' term expire after a three-year term or upon resignation, whichever comes first. The end of the three-year term for each of the At-Large Member falls on a different year for each member and on December 31st, and thus an At-Large Member must be reappointed annually.

Individuals are eligible to be Alternate-at-large members if they are residents of the County and over 18 years of age. Alternate-at-large Board Members are not appointed based on geographic location in the County. Alternate-at-large Board Members' terms expire after three-years or upon resignation, whichever comes first. If the position becomes vacant before the three-year term expires, the newly appointed Member will serve for the remainder of the term.

DISCUSSION:

Alternate Member-At-Large Position No. 2 became vacant upon Pamela K. Whitmire's appointment to Member at Large Position No. 3 at the TCAG Board meeting held April 17, 2021.

Appointees would fill the remainder of the original three-year term set to expire December 31, 2022. The vacant positions notice was posted to the TCAG website on April 18, 2021, and June 15, 2021. TCAG will continue to solicit interest on the TCAG website and social media for the Alternate Member At Large No.2 position until it is filled.

SUBJECT:

Information: Regional Transit Coordination Update

BACKGROUND:

TCAG led the effort to help improve regional transit service by facilitating the creation of a regional transit agency. The Joint Powers Agreement creating the Tulare County Regional Transit Agency (TCRTA) was effective August 11, 2020. Eight member agencies have joined the TCRTA.

DISCUSSION:

The TCRTA is continuing its Fare Free 4 All program. It began on July 1st for all riders on the TCRTA system and ridership has seen moderate but consistent gains to date. TCRTA will continue to monitor ridership. Free fares are expected to last through the end of the calendar year, but the program is dependent on how quickly grant funds are exhausted.

TCRTA submitted a federal grant application for the Areas of Persistent Poverty program. TCRTA worked with TCAG, Visalia Transit, and a number of representatives from major medical providers in the county to develop the scope of work. The grant is for planning only, and if awarded would provide funds for the development of a mobility management program that would primarily coordinate non-emergency medical trips, with a strong focus on reaching residents in rural communities.

Final technical and financial documents are being drafted for submittal to the Federal Transit Agency. It is expected that the TCRTA will be certified as a public transit provider eligible to receive federal funds very soon.
