Upon a motion by Member Valero, and second by Member Micari, the Tulare County Transportation Authority unanimously approved the Authority Consent Calendar Action Items III-A through III-C. Absent: Shuklian, Cox.

**IV. AUTHORITY ACTION/DISCUSSION ITEMS**

**A. Action: Adoption of Resolution: Approve the Measure R Funding for Litter Abatement Pilot (LAP) Program for the City of Porterville**

Ms. Poleszczuk explained that as part of the Sustainable Corridors Committees along with Caltrans, and member agencies, much work had been done to examine methods that could increase liter removal along the region's highways. Ms. Poleszczuk outlined the funding sources for the litter abatement pilot program that was proposed to begin in the City of Porterville and requested the use of Measure R funds to partially fund these efforts.

Upon a motion by Member Valero, and seconded by Member Micari, the Tulare County Transportation Authority unanimously approved the Measure R funding for the litter abatement pilot program as presented. Absent: Shuklian, and Cox.

**B. Action: Adoption of Resolution: Tulare County Transportation Authority (TCTA) Fiscal Audit Consultant Selection**

Mr. Smalley stated that this item was the same as what had been presented during the TCAG meeting and reminded all of the recommendation to select Brown Armstrong CPA to conduct the fiscal audits for FY 2020/21, FY 2021/22, and FY 2022-23.

Upon a motion by Member Boyer, and seconded by Member Townsend, the Tulare County Transportation Authority unanimously approved the selection of Brown Armstrong as the fiscal audit consultant as recommended. Absent: Shuklian, and Cox.

**C. Action: Adoption of Resolution: Approve the Selection of a Financial Consultant for Measure R**

Mr. Smalley reported that KNN Public Finance was the only firm to submit a proposal for this highly specialized request to provide financial consulting services for Measure R and outlined the proposed agreement.

Upon a motion by Member Micari, and seconded by Member Valero, the Tulare County Transportation Authority unanimously approved the selection of KNN Public Finance as the financial consultants for Measure R as recommended. Absent: Shuklian, and Cox.

**D. Information: Member Agency Measure R Audit Year Ending June 30, 2020**

Mr. Smalley stated that the information was simply for the Measure R portion of the audit and just like what had been share from the earlier report given during the TCAG meeting all audits had been completed and did not have any material weaknesses or findings.

**SUBJECT:**

**Action:** Adoption of Resolution: Reaffirm Agreement with Brown Armstrong Accountancy Corporation for Audit Consultant Selection

**BACKGROUND:**

The Tulare County Association of Governments on behalf of the Tulare County Transportation Authority invites the submission of proposals by qualified accounting firms to perform annual fiscal audits of the agency and the selected funds under its jurisdiction. The audits shall be made in accordance with generally accepted auditing standards and shall include all procedures necessary for the retention of an opinion regarding the fairness of the presentation of financial statements in accordance with generally accepted accounting principles.

**DISCUSSION:**

On March 18, 2021, TCAG staff sent out a Request for Proposal (RFP) to 50 firms for the preparation of the TCAG Fiscal Audits. The RFP identified \$45,000 as budgeted for the fiscal audit and \$6,000 for additional services as approved. Two (2) proposals were received. The proposals were from: Brown Armstrong CPAs of Bakersfield, and Price, Paige & Company, of Clovis. Staff recommended the selection of Brown Armstrong CPAs of Bakersfield, On May 17, 2021, with Resolution No. 2021-102, the Board authorized the selection of Brown Armstrong Accountancy Corporation to perform the audit and authorized the staff to enter into an agreement.

**RECOMMENDATIONS:**

As set forth in the attached draft resolution, reaffirm attached agreement with Brown Armstrong Accountancy Corporation for Audit services for FY 2020/2021, 2021/2022 and 2022/2023.

**FISCAL IMPACT:**

The TCTA audit budget was approved with the FY 21/22 Overall Work Program (OWP).

WHEREAS, it was recommended to the TCTA Board of Governors by staff that Brown Armstrong CPA's, be awarded a contract to provide three years of auditing services for Tulare County Transportation Authority for the amount not to exceed \$31,780 a year. Contract extension will be permitted on an annual basis for up to three years following, upon agreement by the TCAG Executive Director and Consultant. If needed, TCAG may also request additional services that fall within the scope of the contract that are not outlined within the Request for Proposal (RFP). Any additional services requested by TCAG will be paid up to an additional amount of \$6,000 per year with prior written approval of TCAG; and

WHEREAS, On May 17, 2021, Resolution No. 2021-102, the Tulare County Transportation Authority board selected Brown Armstrong CPAs for preparation of the TCTA Fiscal Audit and authorized staff to prepare and negotiate a contract.

NOW, THEREFORE, BE IT RESOLVED, that the Tulare County Transportation Authority reaffirms the agreement with Brown Armstrong Accountancy Corporation for professional audit services for FY 2020/2021, 2021/2022 and 2022/2023 for a not to exceed amount of \$31,780.

**THIS AGREEMENT** (“Agreement”) is entered into as of July 1, 2021, between the **TULARE COUNTY TRANSPORTATION AUTHORITY** referred to as (“TCTA”), and Brown Armstrong Accountancy Corporation (“CONTRACTOR”). TCAG and CONTRACTOR are each a “Party” and together are the “Parties” to this Agreement, which is made with reference to the following:

**A. WHEREAS**, TCAG released a Request for Proposals (RFP) for preparation of the Fiscal Audits of the Agency and the selected funds under its jurisdiction and additional services (As Needed) for Fiscal Year’s 2020/2021, 2021/2022 and 2022/2023, for a budgeted amount of \$45,000 and an additional amount of \$6,000 with prior written approval of TCAG and additional budget authority before costs are incurred. Contract extension will be permitted on an annual basis for up to three (3) years following, upon agreement by the TCAG Executive Director and Consultant; and

**B. WHEREAS**, A proposal was submitted by Brown Armstrong Accountancy Corporation to provide said services for \$31,780; and

**C. WHEREAS**, The TCAG Board approved Brown Armstrong Accountancy Corporation to prepare the Fiscal Audits of the Agency and the selected funds under its jurisdiction and additional services (As Needed) on May 17, 2021, Resolution No. 2021-102 in the amount of \$31,780.

**THE PARTIES AGREE AS FOLLOWS:**

- 1. TERM:** This Agreement becomes effective as of July 1, 2021, and expires at 11:59 PM on June 30, 2024, unless earlier terminated as provided below, or unless the Parties extend the term by a written amendment to this Agreement.
- 2. SERVICES:** See attached **Exhibits A**
- 3. CONTRACT BUDGET AND PAYMENT FOR SERVICES:** See attached **Exhibits B**
- 4. INSURANCE:** Before approval of this Agreement by TCAG, CONTRACTOR must file with the Clerk of the Board of Governors of TCAG evidence of the required insurance as set forth in the attached **Exhibit C**.
- 5. SCHEDULE:** See attached **Exhibit D**
- 6. PROJECT STAFF:** **Ms. Rosalva Flores, CPA** will be the Engagement Partner for this Project. **Mr. Thomas Young, CPA** will be the Technical Review Partner. **Mr. Ken Gill, CPA** will be the Engagement Manger. **Marlen Rojas, CPA candidate** will serve as the Engagement Senior. Other staff resources of the firm may be used as necessary.

Such fees, along with other costs of issuance (typically bond and disclosure counsel, underwriter, trustee, etc.), could be paid from the proceeds of the bonds. While the borrowing amount of the transaction is a factor, KNN's transaction fees are rather based upon the complexity of the financing and the scope of the services involved. For example, factors such as senior vs. subordinate liens, the familiarity of the market with the issuer's credit, the use of derivatives, the method of sale, and the amount of time between the start and completion of the financing are all factors considered in the fixed transaction fee.

WHEREAS, the TCAG Board on November 23, 2009 approved the funding for a Measure R financial consultant; and

WHEREAS, a Request for Proposal was released on March 18, 2021 for a deadline submission date of April 22, 2021; and

WHEREAS, one (1) proposal was submitted by KNN Public Finance to provide Financial Advisory Services not to exceed the amount of \$40,000 annually beginning July 1, 2021 through June 30, 2024. The Agreement is for 3 years and can be extended up to 3 years for one year; and

WHEREAS, it was recommended to the Tulare County Transportation Authority by staff that, KNN Public Finance be awarded a contract to provide professional financial advisory services for Measure R in the amount of \$40,000 a year. Contract extension will be permitted on an annual basis for up to three years following, upon agreement by the TCAG Executive Director and Consultant. If needed, TCTA may also request additional services that fall within the scope of the contract that are not outlined within the Request for Proposal (RFP). Any additional services requested by TCTA will be paid up to an additional amount of \$10,000 per year with prior written approval of TCTA, and

WHEREAS, On May 17, 2021, Resolution No. 2021-103, the Tulare County Transportation Authority selected KNN Public Finance LLP to provide Financial Advisory Services.

NOW, THEREFORE, BE IT RESOLVED that the Tulare County Transportation Authority reaffirms the agreement with KNN Public Finance LLP for professional Financial Advisory Services for a not to exceed amount of \$40,000 through 6/30/2024.

**Information:** Measure R Revenues for May 2021

**BACKGROUND:**

On November 7, 2006, the voters of Tulare County approved Measure R, imposing a ½-cent sales tax for transportation within the incorporated and unincorporated area of Tulare County through 2037. The transportation sales tax funds are spent in accordance with the Expenditure Plan that resulted from a joint effort among all the cities and the County of Tulare. The Expenditure Plan reflects the transportation needs of the residents of Tulare County. The plan includes funding for Regional Projects, Local Programs, Transit/Bike/Environmental Programs and Administration. The funds are distributed as follows:

1. Regional Projects (50%)
2. Local Programs (35%)
3. Transit/Bike/Environmental (14%)
4. Administration and Planning Program (1%)

Measure R revenue collection began on April 1, 2007. Monthly Measure R advancements are received by TCAG from the State Board of Equalization followed by quarterly clean-up disbursements. In total, TCAG receives eight advancements and four clean-up disbursements throughout a fiscal year.

The Measure R 2020 Strategic Work Plan was approved by the Authority on October 19, 2020 with Resolution No. 2020-119, amended on December 14, 2020 with Resolution No. 2020-120, and amended on April 19, 2021 with Resolution No. 2021-100.

**DISCUSSION:**

**Status of Measure R Revenues**

Fiscal Year 2020/2021 - Measure R allocations have been received, payment request and distribution made through May 2021. The allocation for the month of May is \$4,041,099. compared to the \$2,672,016 for the same period last year. The 20/21 fiscal year to date amount is \$37,908,352 compared to \$31,808,984 for the same period last year, representing a 19% increase for the fiscal year.
