Upon motion by Member Thusu and seconded by Member Caudillo the Tulare County Regional Transit Agency unanimously approved the Consent Calendar Action Items V-A through V-D.

## VIII. ACTION AND INFORMATION ITEMS:

# A. Action: Notice of Intent to Award – Transit Operations Services

Mr. Tree stated that an RFP went out for Transit Operation Services back in December of 2021 and an evaluation committee was created to establish and determine responsiveness of Proposers, determine responsible Proposers, determine ranking based on evaluation matrix points rated by the evaluation Committee, identify the proposals that fall within the competitive range, which would be those proposals that are responsive, responsible, and whose total points from the evaluation matrix are clear leaders amongst the Proposers, request Best and Final Offers, as necessary, of those within the competitive range, and recommend an award on Best Value of those within the competitive range. The evaluation committee had determined that it was not necessary to afford proposers an opportunity to amend their proposal and make a best and final offer. The following is the ranking of the proposals by the selection committee 1 Transdev, 2 First Transit, 3 National Express, and 4 MV Transportation and any proposers can submit a protest if they follow the requirements. TCRTA has selected Transdev Services, Inc. for Transportation Operation Services.

Upon motion by Member Stowe and seconded by Member Garver the Tulare County Regional Transit Agency unanimously approve the recommendations as presented.

# B. Action: Accepting and Appropriating \$3 million in STBGP funding for Zero-Emission Vehicles and Related Charging Infrastructure

Mr. Tree stated that Tulare County Association of Governments (TCAG) meeting held on April 18, 2022, TCAG redistributed up to \$3 million in Surface Transportation Block Grant Program (STBGP) funding to TCRTA to assist the agency in purchasing zero-emission vehicles and related charging infrastructure and TCAG is requesting that STBGP funds be repaid with local transportation funds (LTF) over a period of five years.

Upon motion by Member Thusu and seconded by Member Sigala the Tulare County Regional Transit Agency unanimously approve the recommendations as presented.

## **SUBJECT:**

Action: Reaffirm Conditions of State Assembly Bill 361 to Continue Remote Attendance

#### **BACKGROUND:**

In response to the COVID-19 pandemic, the Governor suspended part of the Brown Act concerning the requirements for allowing Governing Board members to remotely participate in Board meetings. The suspended provisions require that 1) Governing Board meeting agendas allowing remote Board Member participation list each of the specific locations from which Board members will be remotely participating, 2) such agendas be posted at each such location, and 3) members of the public must be allowed to remotely participate in the meeting from each of the listed locations. The suspension was done to promote social distancing and so to help limit the spread of COVID-19.

## **DISCUSSION:**

The Governor's suspension of these Brown Act provisions expired as of September 30, 2021, and was replaced by State Assembly Bill (AB) 361, an urgency statute that became effective as of September 30, 2021. Under AB 361, Governing Boards can continue to allow remote Board members participation in Brown Act public meetings if several conditions are met:

- 1. The meeting is held during a declared State of Emergency (Like the Governor's COVID-19 pandemic State of Emergency that's still in effect in California);
- 2. The Governing Board adopts findings to the effect that allowing remote meeting participation by Governing Board members promotes social distancing, which in turn helps prevent the spread of COVID-19;
- 3. The Governing Board confirms these conditions continue to be met every 30 days.

The Tulare County Regional Transit Agency Board of Directors passed a resolution adopting a policy of remote attendance pursuant to AB 361 on October 18, 2021.

#### **RECOMMENDATION:**

That the Tulare County Regional Transit Agency Board of Directors reaffirm Resolution No. 2021-11 to continue to participate in its governing board meetings remotely by the teleconferencing provisions of AB 361.

# **SUBJECT:**

**Action:** Public Hearing on 2022 Fare and Service Changes

#### **BACKGROUND:**

At the Board meeting of January 24, 2022, the Board of Directors authorized a public hearing for the 2022 fare and service changes and directed staff to prepare an outreach plan to ensure public participation.

At the Board meeting of February 28, 2022, the Board of Directors approved a series of virtual community meetings to inform the public of the proposed 2022 fare and service changes, survey the public on the proposed changes, and create a website, tcrtacares.com, to inform the public on the proposed changes. Virtual community meetings were held on April 27, 2022, April 28, 2022, May 4, 2022, and May 5, 2022.

As of May 10, 2022, the tcrtacares.com website received 837 page views, 340 site sessions, and 308 unique visitors. The four virtual community meetings that were available on Facebook Live reached 956 people with 110 engagements. Regarding the community survey, the agency received 76 submissions.

Staff published the required legal notice in a local newspaper. In addition, information on the proposed fare and service changes were posted on the TCRTAcares website, and printed materials were distributed to the riding public. A range of social media posts directed the public to the Agency's website for further information. The public was invited to submit comments at the public hearing or via email to staff.

TCRTAcares.com analytics and survey results and comments have been attached.

# **DISCUSSION:**

The proposed 2022 fare and service changes included the following:

- 1. Restore Fare Collection.
- 2. Adopt 2022 TCRTA Fares Schedule.
- 3. Replace local flex routes, TCaT Routes 50 and 60, with on-demand service.
- 4. Create uniformity in the local fixed route schedule across the TCRTA system. Currently, local fixed routes have unique service hours for each individual member agency. The uniform schedule will have all local fixed routes operating on the same service hours

and on the same days. It is proposed that local fixed routes operate Monday – Saturday from 7:00 am to 7:00 pm, and limited Sunday service from 8:00 am to 5:00 pm.

- 5. Create uniformity in the ADA paratransit schedule across the TCRTA system. ADA regulations require that ADA paratransit operate on the same days and hours of the local fixed route system, therefore the current ADA paratransit schedule is unique to each member agency's fixed route service. This service change will insure TCRTA is ADA compliant regarding paratransit service. It is proposed that ADA paratransit service operate Monday Saturday from 7:00 am to 7:00 pm, and limited Sunday service from 8:00 am to 5:00 pm.
- 6. Create uniformity in the On-Demand schedule across the TCRTA system. On-Demand service is being planned to expand to all member agencies starting next fiscal year. It is proposed that On-Demand service operate Monday Saturday from 6:00 am to 10:00 pm, and limited Sunday service from 8:00 am to 8:00 pm.

# **RECOMMENDATION:**

That the Tulare County Regional Transit Agency Board of Directors:

- 1. Conduct a public hearing to receive public comment on the proposed 2022 fare and service changes;
- 2. Consider adopting the draft resolution restoring fare collection and the 2022 fare schedule effective September 1, 2022; and
- 3. Consider adopting the draft resolution for the 2022 service changes effective July 1, 2022.

## **FISCAL IMPACT:**

All activities associated with the 2022 fare and service changes will be included in the FY 2022 budget.


















# SURVEY COMMENTS

As for fares, there shouldn't be an increase because people ride the bus because its affordable. If there's a drastic change, people will not ride the bus. Some of us ride the bus because the gas is expensive so making the fare higher will be a problem too.

# **SUBJECT:**

**Action:** Transit Safety and Security

#### **BACKGROUND:**

Over the past year safety and security incidents have increased at TCRTA transit centers and on buses. These increases have led to increased expenses and a rise in safety and security concerns for both passengers and employees.

One of the most significant barriers for transit operators is the perception that transit is unsafe. Historically, transit agencies have sought to create a sense of safety and security through the use of police presence. However, this approach has shortcomings as it has placed an unjust burden on the local police department having to respond to non-violent offenses.

Currently, TCRTA does not have security guards at its transit centers. Visalia Transit has a minimum of two security guards at its transit center from 6:00 a.m. to 10:00 p.m.

The Federal Transit Administration requires grantees to invest a minimum of two percent (2%) of its total budget in safety and security.

## **DISCUSSION:**

Safety of Passenger and Employee is TCRTA's top priority. Due to the increase in safety and security incidents, staff has started to draft its Public Transportation Agency Safety Plan which will include the following:

- 1. Designation of a Chief Safety Officer.
- 2. TCRTA Safety Management Policy.
- 3. Process for Safety Risk Management, Safety Assurances, and Safety Promotion.
- 4. Employee Reporting Tool.
- 5. Performance Targets based on safety performance measures established in FTA's National Public Transportation Safety Plan.

#### **RECOMMENDATION:**

That the Tulare County Regional Transit Agency Board of Directors provide direction on how to address the increase in safety and security concerns for both passengers and employees.

#### **FISCAL IMPACT:**

Any activities authorized by the Board of Directors will be included in the 2022 budget.
