Discussion: America's Open and Transit's Open – Strategies to Renew Ridership

DISCUSSION:

On July 21, 2021, the Federal Transit Administration (FTA) announced the America's Open and Transit's Open initiative to help transit agencies across America rebuild and enhance ridership.

The American Rescue Plan and other pandemic relief grants have provided critical funding to transit agencies nationwide, including covering expenses for cleaning and other measures to improve safety.

Staff proposes the following 10-step strategy to renew ridership, build public confidence in transit, and increase ridership with a focus on building community partnerships.

TCRTA's 10 Steps to Renew Ridership – Ride Safe & Ride TCRTA

- 1. TCRTA Website & Social Media Accounts
- 2. Return to Normal Operational Status and Capacity
- 3. Fare Free 4 All
- 4. Enhanced Fleet and Facility Cleaning
- 5. Next Generation Fare Payment System
- 6. Real-Time Transit Information
- 7. Visual Indicators
- 8. Community Outreach
- 9. Healthy Workforce
- 10. Innovative Mobility

SUBJECT:

Discussion: New Membership – Tule River Tribe of California

DISCUSSION:

On December 30, 2013, the Tule River Tribe of California was recognized, and has received funding, as a recipient of Federal Transit Administration (FTA) Tribal Transit Formula Program (Section 5311 c) for the purposes of capital, operating, planning, and administrative expenses for public transit projects that meet the growing needs of rural tribal communities.

Since this time, the City of Porterville has provided administrative assistance to the Tule River Tribe in the development of its Tribal Transit Program, including the purchase of a vehicle, bus stop shelters, and other enhancement projects. The Tule River Tribe has also received operating assistance to start its service but needs assistance managing and operating its services.

Staff from the Tule River Tribe of California has expressed interest in becoming a member of the Transit Agency and has Tribal Transit funding for its share of transportation services within its community.

The Joint Power Agreement, Section 10: New Members, states that if a city within the County of Tulare not a Party of this Agreement desires to join the Transit Agency, it may become a Member Agency subject to such terms and conditions as may be prescribed by the Board. Upon becoming a Member Agency, the new Member Agency shall become responsible for its share of the funding for public transportation provided by the Transit Agency.

Staff recommends consideration in amending the Joint Powers Agreement to allow all public transportation operators, located in Tulare County, to be eligible as a new member.

SUBJECT:

Discussion: Planning, Staffing and Office Update

DISCUSSION:

The Tulare County Association of Governments (TCAG) has identified funding to assist the Agency in developing the following planning activities:

- Short Range Transit Plan (Lite Version)
- Zero-Emission Bus Rollout and Innovative Mobility Plan
- Branding and Outreach

TCAG has also identified funding for a part-time Associate Regional Planner to serve as a project manager for the various TCRTA planning activities and assist TCRTA in the development of its Short Range Transit Plan (Lite Version).

To accommodate the growing number of staff needed to administer the Agency's activities, staff has been in discussion with TCAG to amend its property lease to include two additional office spaces located within the same property.

The monthly cost of the two additional office spaces will be \$900. An annual 3% increase will be effective January 1, 2022 and expire with the TCAG Lease Agreement in 2026. The monthly cost of the office space lease has been budgeted in the FY 21/22 Budget.

Staff has identified the following additional expenses required to make the office spaces workable:

Furniture	\$14,601.59
Workstation and	\$5,263.29
Monitors	
Office Phones	\$1,045.52
Access Control	\$2,000.00
Renovation/Remodel	\$2,000.00
Contingency	\$5,000.00
Total	\$29,910.40

Staff has identified several activities within the FY 21/22 Budget that can be reduced to fund the office expenses without requiring additional revenues. Cost savings have been identified in the areas of salaries and employee benefits and in publications, dues and legal notices.

Staff recommends presenting a zero-dollar FY 21/22 Budget Amendment at the Board meeting scheduled for August 16, 2021. Staff also recommends authorizing the office furniture and equipment at a total cost not to exceed \$29,910.40. Furniture and equipment will be procured following existing County contracts and the California Multiple Award Schedule (CMAS).
